Failure to appear could result in judgment being entered against such non-appearing party, or where Plaintiff fails to appear, dismissal of the case without prejudice, or non-appearance by a party could result in other sanctions imposed.

It is Ordered that this calendar and Order be entered on the minutes of the Court and be posted in the Office of the Clerk of this Court.
