Cases not reached on a particular date shall continue to be subject to being called for trial later in the week scheduled for trials in the order appearing on the calendar, unless otherwise directed by the Court.

Counsel or a party where not represented by Counsel shall be under a duty to keep informed of the status of the calendar. Immediately upon settlement, dismissal of case, or problem with a case, the involved attorneys or party shall forthwith notify the Court without delay.

Cases will be called in the order fixed above except by special leave of the Court or by showing for continuance properly made.
