
ORDER

The undersigned representing all the Judges of the Western Judicial Circuit hereby elect to delegate to **Benjamin R. Makin**, Chief Magistrate of Athens-Clarke County, and **Donarell R. Green, IV**, Judge of the Magistrate of Athens-Clarke County, the authority to set bail on bench warrants issued by a Judge of the Superior Court of Athens-Clarke County based upon direct indictments returned by the Grand Jury of Athens-Clarke County. This delegation shall only apply to bench warrants for offenses which are bailable by a Judge of the Magistrate Court and shall not apply to any bench warrant including any offense which is bailable only before a Judge of the Superior Court.



This delegation shall be valid from **January 1, 2022 – December 31, 2022**, but may be revoked by the undersigned at any time prior to the end of this one year period. 


