ORDER CREATING DOCKET FOR DOMESTIC RELATIONS CIVIL ACTIONS

FILED BY SELF-REPRESENTED LITIGANTS

WHEREAS, the Judges of the Superior Courts of the Western Judicial Circuit recognize a significant increase in the filings of Domestic Relations Civil Actions filed by Self-Represented Litigants; and

WHEREAS, the Judges of the Superior Courts of the Western Judicial Circuit recognize a need for there to be consistency in the pleadings and required documentation filed with the pleadings in the case, as well as the need to provide information to Self-Represented Litigants, and in order to provide the public with reasonable access to the court system;

NOW THEREFORE,

1. The Clerk of the Superior Court of Clarke County, Georgia, and the Clerk of the Superior Court of Oconee County, Georgia, SHALL PLACE ALL PENDING AND FUTURE DOMESTIC RELATIONS CIVIL ACTIONS filed by a Self-Represented Litigant on a separate docket.

2. The Clerk of the Superior Court of Clarke County, Georgia, and the Clerk of the Superior Court of Oconee County, Georgia, SHALL ASSIGN ALL PENDING AND FUTURE DOMESTIC RELATIONS CIVIL ACTIONS filed by a Self-Represented Litigant to Superior

Court Judge Lisa Lott.


