

**General Presentment and Reports  
Athens-Clarke County Grand Jury  
July 12- October 8, 2021**

On July 15, 2021, 25 jurors, including two alternates were selected to serve as members of the Grand Jury for the Athens-Clarke County Superior Court for the July 2021 term. Judge Patrick Haggard administered the oath to the jurors and charged them with their responsibilities.

The jurors elected Malcolm McArthur as Foreperson, Julie Boyd as Assistant Foreperson, Lisa Griffin as Secretary, and Sarah Robertson as Assistant Secretary.

**I. Criminal Functions**

In connection with the criminal function of the Grand Jury, 25 cases were brought before the Grand Jury for indictment. Of these cases 24 were returned as True Bills, none were returned as No Bills, and one was returned as a Split Bill.

**II. Civil Functions**

The July 2021 Grand Jury was charged with appointing a regular member of the Board of Tax Equalization for a three year term beginning January 1, 2022 and appointed Patricia Murray to fill this position.




