General Presentment and Reports

Athens-Clarke County Grand Jury

Second Quarter Session 2023

One the 11th day of April 2023 the Honorable Judge Lisa Lott selected a jury of 25 people including two alternates to the grand jury. Judge Lisa Lott then administered the oath and charged them with their responsibilities.

The jurors then elected Allison Sears as Foreperson, Joshua Sweat as Assistant Foreperson, Rachel Watkins as Secretary, and Kallie Brunson as Assistant Secretary.

The remaining jurors were Josephine Wingfield, Jenna Elizabeth Andrews-Swann, Benial Hailey, Jr., Maggie Grace Miller, Tyler Brown, David George Whitfield, Jr., Wintre Servel Howard, Raul F. Nima Alcedo, Cindy Marie Allen, Cecilia McGregor, James E. Gaffney, Christopher Keith Neace, Laura Kellum Rhicard, Keshundra Katrice Watkins, Lisa Dianne Childress, Amy Lynn Thompson, Kaori Sakamoto, Emily Wallace Saye, and Timothy Reece Cain. Alternate jurors were Carl R. Satterfield and Laurie A. Fox.

General Observations

While this jury knows how understaffed the current office of the District Attorney is, we want to commend the office of the District Attorney and the officers and witnesses, and thank them for their efforts to maintain the law in Athens Clarke County. This jury was able to make quick informed decisions thanks to prepared and present witnesses from the GBI, ACCPD, Attorney General's Office and office of the District Attorney.

Closing Remarks

We ask that the court raise the compensation rate grand jurors are given from \$35 a day to \$50 a day. This increase would help those who do not get paid by their employers for time missed. It has been proposed by this jury that there be higher compensation for those holding foreperson, secretary, assistant foreperson and assistant secretary roles; as well as a pool for salaried jurors to donate to to offset hourly jurors time at work missed.

We also suggest that the court provide the foreperson, assistant foreperson, secretary and assistant secretary with a document outlining their duties and responsibilities during the grand jury session in addition to the juror handbook. These documents should include a guideline for this document as well as a schedule of days in session. Furthermore, a similar document should be given to the presenting attorney with guidelines on the role and how to read indictments and ask open ended, non-leading questions of witnesses. It has also been proposed to have a guideline for how the jury room should be left when not in use.

We also suggest a mock case be read and orientation be done presenting the juror handbook and foreperson/secretary documents in preparation for the first day in session. This jury would have felt much more prepared to perform our civil duty had these steps been taken post jury selection. We propose that this happen the same day as jury selection and prior to allowing the jury to select foreperson, secretary, assistant foreperson and assistant secretary.
