

**General Presentment and Reports
Athens-Clarke County Grand Jury
January 2025 Term**

On January 21, 2025, 25 jurors, including two alternates, were selected to serve as members of the Grand Jury for the Athens-Clarke County Superior Court for the January 2025 term. Judge Patrick Haggard administered the oath to the jurors and charged them with their responsibilities.

The jurors elected Daniela Wieczorek as Foreperson; Sean Boyle as Assistant Foreperson; Latasha Adebisi as Secretary and Gabrielle Rose as Assistant Secretary.

I. Criminal Functions

This activity took place over eight sessions (Feb February 4, 11, 18,25; March 4,11,18,25, April 1 and April 8).











II. Civil Functions
