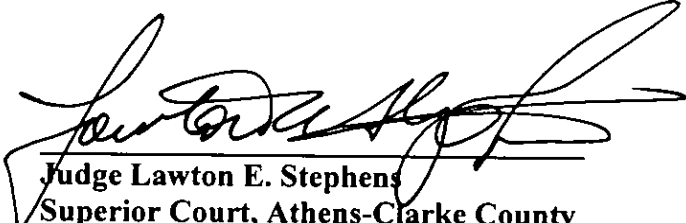

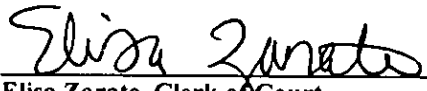
Penalty:

**General Presentment and Reports
Athens-Clarke County Grand Jury
July 2025 Term**

On July 14, 2025, 25 jurors, including two alternates, were selected to serve as members of the Grand Jury for the Athens-Clarke County Superior Court for the July 2025 term. Judge Lawton E. Stephens administered the oath to the jurors and charged them with their responsibilities.

The jurors elected Diana Harrell as Foreperson; April Andrews as Assistant Foreperson; Julie Lanard as Secretary Secretary, and April Cunningham as Assistant Secretary.

I. Criminal Functions

In the capacity of the criminal functions of the Grand Jury, about 198 cases were brought before the Grand Jury for indictment. Of these cases, 182 were returned as True Bills, 7 were returned as No Bills, and 9 were returned as Split Bills. This activity took place over 13 sessions (July 15, 22, 29; August 05, 12, 19, 26; September 02, 09, 16, 23, 30; and October 07).

There were no Civil Functions addressed in this session of the Grand Jury.
