Cases will be called in the order fixed, except by special leave of the Court.


Cases will be taken off the non-jury calendar only by special leave of the Court or by showing for continuance properly made.

Court will open at **9:30 a.m.** on date specified in the Athens-Clarke County Courthouse, Athens, Georgia.

Failure to appear could result in judgment being entered against such non-appearing party, or where Plaintiff fails to appear dismissal of the case without prejudice or non-appearance by a party could result in other sanctions imposed.

It is Ordered that this calendar and order be entered on the minutes of the Court and be posted in the Office of the Clerk of this Court.
