PRE-TRIAL CALENDAR

The cases on the enclosed calendar are set for pre-trial conference before the undersigned Judge of the Superior Court in the **Athens-Clarke County Courthouse, Athens, Georgia at 9:00 a.m. on the 22nd day of March 2022.**

The attorney to try the case or a party where unrepresented by counsel shall attend the pre-trial conference.

Counsel for each party, after conferring, shall jointly prepare and present at the pre-trial conference a written proposed consolidated pre-trial order in the form specified by Rule 7.2 of The Uniform Superior Court Rules and with the information required thereby. If there are any issues on which counsel cannot agree the areas of disagreement must be shown in the proposed pre-trial order. Plaintiff's counsel shall contact defense counsel to arrange a time to discuss the drafting of a proposed pre-trial order to present the Court.

Failure of counsel or an unrepresented party to appear at the pre-trial conference without legal excuse or to present a proposed pre-trial order shall authorize the Court to remove the action from any trial calendar, enter such pre-trial order as the Court shall deem appropriate, or impose any other appropriate sanction, except dismissal of the action with prejudice.

Counsel will be prepared to stipulate to the maximum extent possible at the pre-trial conference with respect to the admissibility of exhibits and documentary evidence and with respect to matters not in issue between the parties.

Any motions not previously ruled on will be called to the Court's attention at the pre-trial conference and will be considered at that time.

Any reference to counsel is applicable to a party where unrepresented by counsel.

TRIAL WEEK

The attached calendar is prescribed for the jury trial of civil cases before Chief Judge Eric W. Norris for the week of **May 2, 2022, in the April 2022 Term** of the Superior Court of Athens-Clarke County, Georgia. Trials shall be conducted in the Athens-Clarke County Courthouse, Athens, Georgia. Court will open at **9:00 a.m.** on the dates specified, unless otherwise directed by the Court.

The parties and Counsel in these actions appearing on the trial calendar for a particular date shall appear and be ready for trial on the dates specified as per Rule 8.4 of the Uniform Rules of the Superior Court, unless otherwise directed by the Court.

With settlement, dismissal or removal of a case from the trial calendar, the cases immediately following the same shall move up and assume the status of the preceding case or cases so removed from the calendar and the trial date specified therefor. Cases not reached on a particular date shall continue to be subject to being called for trial later in the week scheduled for trials in the order appearing on the calendar, unless otherwise directed by the Court.

Counsel or a party where not represented by Counsel shall be under a duty to keep informed of the status of the calendar. Immediately upon settlement, dismissal of a case, or problem with a case, the involved attorneys or party shall forthwith notify the Court without delay.

Cases will be called in the order fixed above except by special leave of Court or by showing for continuance properly made.

It is ordered that this calendar and order be entered on the Minutes of the Court.
