

If a Plaintiff wishes to have a case removed from this calendar, the request must be in writing specifying a good cause basis for the request (i.e., service will be re-attempted at a new address, a special agent for process is being requested, etc.), and must be filed and submitted to the Court no later than **Friday, June 27, 2025**. Where a request for excusal is based upon Plaintiff's intent to dismiss a case, the dismissal must be filed with the Clerk of State Court prior to the hearing of this calendar.
