Cases will be called in the order fixed, except by special leave of the Court.

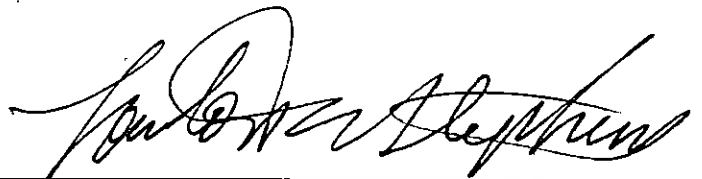
Cases will be taken off of the non-jury calendar only by special leave of the Court or by showing for continuance properly made.

Court will open at **9:30 a.m.** on the date specified in the Athens-Clarke County Courthouse, Athens, Georgia.

Failure to appear could result in judgment being entered against such non-appearing party, or where Plaintiff fails to appear, dismissal of the case without prejudice or non-appearance by a party could result in other sanctions imposed.
